The presentation of the AFPM Safety Award plaques is part of a comprehensive safety awards program which the Association's Safety & Health Committee has developed to promote safety performance achievements in the petroleum refining, petrochemical manufacturing, and contracting industries and to publicly recognize the excellent record of safety in operations which the industries and contractors have achieved.

AFPM Safety Awards are based on records kept for employees in accordance with OSHA record keeping requirements as defined by law and entered on the OSHA 300A summary form and API RP 754, *Process Safety Performance Indicators for the Refining and Petrochemical Industries*.

The Safety Awards Program honors AFPM Regular member companies operating U.S. refineries and petrochemical manufacturing plants as well as Associate member contractors working in those facilities. The program consists of the following awards.

### DISTINGUISHED SAFETY AWARD

AFPM's most prestigious award, the Distinguished Safety Award (DSA) recognizes those member company refineries and petrochemical plants that have attained a sustained, exemplary level of safety performance in the domestic refining and petrochemical manufacturing industries. Recipients are chosen by a selection committee composed of members of the AFPM Safety & Health Committee. It is the DSA Selection Committee's responsibility to carefully examine the safety performance records of individual plant locations using the specific screening and selection criteria detailed below.

### ELITE GOLD SAFETY AWARD

This award is presented to the top one percent of member company refineries and petrochemical plants that have exhibited superior safety performance and program innovation as determined by the DSA Selection Committee.

### ELITE SILVER SAFETY AWARD

This award is presented to the top five percent of member company refineries and petrochemical plants that have exhibited excellent industry safety performance and program innovation as determined by the DSA Selection Committee.

## DISTINGUISHED SAFETY AWARD

---

### Screening Criteria

In order to qualify for the DSA, a facility must first pass the screening criteria as described below:

1. A location must achieve the following requirements for the calendar year:
  - a. an employee total recordable incidence rate (TRIR) of 0.3 or less,
  - b. a contractor total recordable incidence rate (TRIR) of 0.3 or less,
2. A location must have had no employee workplace related fatalities and no non-employee (contractor, visitor, etc.) workplace related fatalities for the previous five consecutive years.

A location must answer **no** to the following questions:

1. Did the location experience a community evacuation or sheltering event, or worker/contractor hospitalization (admitted for treatment) during the evaluation period?
2. Did the location experience a recordable injury where any of the following caused or contributed to the injury during the evaluation year?
  - Failure to isolate hazardous energy (lockout/tagout)
  - Opening process equipment not properly prepared for maintenance
  - Improperly prepared or hazardous confined Space
  - Improperly prepared or hazardous excavation
  - Any falls from height (>4 feet)
  - Any Tier 1 or 2 Process Safety Event (PSE)
  - Contact/exposure to hazardous materials (physical and chemical)
  - H2S, HF, Hydrocarbons, Corrosives, Electricity, Radiation, Excessive Heat, etc.
  - Any crane or rigging failure
3. Did the location have any API RP Tier 1 Process Safety Events (PSE) that **required** notification to the National Response Center during the evaluation year?

### Selection Criteria

After passing the screening criteria, the candidate facility's overall safety performance record will be evaluated by the selection committee based on the applicant's written application. Those sites that are in the running for the DSA and Elite Gold awards participate in in-person interviews with representatives of the DSA Selection Committee.

## SAFETY ACHIEVEMENT AWARD (OPERATING MEMBERS)

---

### Screening Criteria

In order to qualify for the Safety Achievement Award, a facility must first pass the following screening criteria.

1. A location must achieve an employee total recordable incidence rate (TRIR) of **0.45** or less for the calendar year:
2. A location must have had no employee workplace related fatalities and no non-employee (contractor, visitor, etc.) workplace related fatalities for the reporting year.

A location must answer **NO** to the following questions to pass the screening criteria and be eligible to apply for the Safety Achievement award:

3. Did the location experience an injury to a **company employee** that required hospitalization (admitted for treatment) during the evaluation period?
4. Did the location experience a **company employee** recordable injury where any of the following caused or contributed to the injury during the evaluation year?
  - Failure to isolate hazardous energy (lockout/tagout)
  - Opening process equipment not properly prepared for maintenance
  - Improperly prepared or hazardous confined space
  - Improperly prepared or hazardous excavation
  - Any falls from height (>4 feet)
  - Any Tier 1 or 2 Process Safety Event (PSE)
  - Contact/exposure to hazardous materials (physical and chemical)
  - H2S, HF, Hydrocarbons, Corrosives, Electricity, Radiation, Excessive Heat, etc.
  - Any crane or rigging failure
5. Did the location experience a community evacuation or sheltering event during the evaluation period?
6. Did the location have any API RP Tier 1 Process Safety Events (PSE) that **required** notification to the National Response Center during the evaluation year?

## CONTRACTOR SAFETY ACHIEVEMENT AWARD

---

This award recognizes maintenance contractors working a minimum of 20,000 hours per calendar year at a regular member facility.

### **Section 1: Injury & Illness Data**

The contractor company at the location submits this information for data analysis only:

Total Hours Worked  
Total Fatalities (G)  
Cases with Days Away From Work (H)  
Cases with Job Transfer or Restriction (I)  
Other Recordable Cases (J)  
Days Away From Work (K)  
Days with Transfer or Restriction (L)  
DART  
Total Recordable Incident Rate

### **Section 2: Incident Severity Screening Criteria**

The contractor company at the location must answer NO to the following questions to be eligible for the award:

- Did the contractor company at the location experience an event where an employee was hospitalized (admitted for treatment) during the evaluation period?
- Did the contractor company at the location experience an event where an employee had an amputation during the evaluation period?
- Did the contractor company at the location experience an event that resulted in a workplace fatality?
- Did the contractor company at the location experience a recordable injury where any of the following caused or contributed to the injury during the evaluation period:
  - Failure to verify hazardous energy isolation (lockout/tag out)?
  - Opening process equipment not properly prepared for maintenance?
  - Improperly prepared or hazardous confined space?
  - Improperly prepared or hazardous excavation?
  - Any falls from height (>4 feet)?
  - Contact/exposure to hazardous materials (physical and chemical) such as: H2S, HF, Hydrocarbons, Corrosives, Electricity, Radiation, Excessive Heat, Etc.?
- Any crane or rigging failure?

**Section 3: Participation and Best Practices**

The contractor company at the location must meet a minimum score of 25 points to be eligible to apply for the award:

Site Safety Processes / Initiatives (Contractor Safety Forums, Focus Teams, etc.)

- Implements timely with an active participation level in the development/deployment = 10
- Implements as required with no additional involvement = 5
- Doesn't support or promote with minimal required participation = 0

Audit Process / Employee Observation

- Most employees and supervisors are involved and follow-ups are completed with action plans = 10
- Good involvement but no formal follow-up = 5
- No program in place = 0

Short Service Worker / Mentoring Process

- Formal mentorship program/process for new employees = 10
- Informal mentoring process = 5
- No program in place = 0

Near Miss Reporting Program

- Actively reports near misses with a reporting process that includes high potential and significant events = 10
- Informal near miss reporting process = 5
- No program in place = 0

VPP

- OSHA VPP Recognition (Star, Demonstration, Mobile Workforce, Challenge, SHARP) = 10
- VPP Application Submitted / In Process = 5
