



PRIVATE DINING OVERVIEW

Dining Rooms | Arnaud's features seventeen beautiful dining rooms, seating 2-220 guests (hosting up to 1000 guests for a reception), each uniquely appointed with exquisite New Orleans style.

DINING ROOM ASSIGNMENTS | Private Dining Rooms are assigned by Arnaud's based upon the final guest count guaranteed. Arnaud's reserves the right to re-assign private rooms based upon fluctuations in anticipated attendance figures. A minimum food and beverage revenue is only required for exclusive use of specific private and a la carte dining rooms.

MENU AND WINE SELECTION | Arnaud's offers classic Creole cuisine. Parties of thirteen guests or more must pre-select a menu. Guests may custom design menus or choose from a selection of menu packages. Any dietary restrictions will be specifically catered to by the Chef. Due to the seasonality and market availability of our menu, prices are subject to change. Food and Beverage are not permitted from outside of Arnaud's with the exception of certain specialty cakes. Menu and wine selections must be confirmed ten business days prior to the contracted event date.

MOBILITY IMPAIRED | Arnaud's offers one private dining room with wheelchair accessibility. The remaining private dining rooms are located on the second floor and are not accessible by elevator. Please inform the private dining event coordinator of any special access needs.

FIRST OPTION HOLD | Private dining rooms may be tentatively held on a first option basis. If another group inquires about a space held, we will give you notice to exercise your option and book on a definite basis. If you do not sign a contract within 24 hours of the option notice, the space will be released to the other party.

CONTRACTS, DEPOSITS AND PAYMENT | Private party reservations are only considered definite with a signed Event Agreement and payment of the required deposits, as follows:

Private Rooms (except Count's Ballroom): A deposit of \$50.00 per person, based upon the minimum guest count specified, is required with the signed Event Agreement.

Count's Ballroom: A deposit of \$25.00 per person, based upon the minimum guest count specified, is required with the signed Event Agreement. An additional deposit of \$25.00 per person, based upon the minimum guest count specified, is required 60 days before your event.

Main Dining Room, Jazz Bistro, French 75 and Remoulade Buyouts: A non-refundable deposit of 10% of the required minimum food and beverage revenue is required when we receive this signed Agreement and an additional payment of 40% must be paid 90 days before your event.

The balance is to be settled the day of the event. We welcome payment by cash, company check, American Express, Visa, MasterCard, and Discover Card.



GUARANTEES | Arnaud's requires a minimum guaranteed number of guests confirmed three (3) business days prior to the event. If the number in the party is less than the guaranteed number, the final charge will be based on the guaranteed number of guests.

CANCELLATION | Should the event be cancelled in its entirety the following fees shall be assessed:

Private Dining Rooms (except Count's Ballroom):

If the event cancels less than two weeks but more than 72 hours before the contracted event date, the deposit will be forfeited.

If the event cancels less than 72 hours before the contracted event date, we will charge \$75.00 per person (based upon the guaranteed guest count) less the deposit specified above.

Count's Ballroom:

If the event cancels less than 60 days but more than 72 hours before the contracted event date, the deposit will be forfeited.

If the event cancels less than 72 hours before the contracted event date, we will charge \$75.00 per person (based upon the guaranteed guest count) less the deposit specified above.

Main Dining Room, Jazz Bistro, French 75 and Remoulade Buyouts:

If the event cancels 90 days before the contracted event date, the 50% deposit will be forfeited.

If the event cancels within 72 hours of the contracted event date, we will charge the balance of the required minimum food and beverage revenue.

FLORAL DECORATIONS AND CUSTOM LINENS | The private dining event coordinator can arrange floral arrangements, themed decorations and custom linens.

AUDIO VISUAL EQUIPMENT AND ENTERTAINMENT | The private dining event coordinator can arrange audio visual equipment, musicians and/or other forms of entertainment. Arnaud's does not permit audio visual equipment and/or entertainment in the private dining rooms without prior approval.

CUSTOM PRINTED MENUS | Arnaud's provides custom printed menus on white card stock for each event. The menu may be customized with personalized text.

DRESS CODE | Collared shirts are required for gentlemen and jackets are preferred. No shorts, t-shirts or flip-flops are permitted. If you have a specific dress code request, please contact someone with our Private Dining Sales Team.
